**SANTA MARIA KARTING ASSOCIATION (SMKA)  
RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT**

**IN CONSIDERATION** of being permitted to enter for any purpose any RESTRICTED AREA (herein defined as including but not limited to the racing surface, pit areas, infield, burn out area, approach area, shut down area, and all walkways, concessions and other areas appurtenant to any area where any activity related to the event shall take place), or being permitted to compete, officiate, observe, work for, or for any purpose participate in any way in the event, EACH OF THE UNDERSIGNED, for himself, his personal representatives, heirs, and next of kin, acknowledges, agrees and represents that he has, or will immediately upon entering any of such restricted areas, and will continuously thereafter, inspect such restricted area or areas and his participation, if any, in the event constitutes an acknowledgement that he has inspected such restricted area and that he finds and accepts the same as being safe and reasonably suited for the purpose of his use, and he further agrees and warrants that if, at any time, he is in or about restricted areas and he feels anything to be unsafe, he will immediately advise the officials of such and will leave the restricted areas:

**1. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE** the promoter, participants, racing association, sanctioning organization or any subdivision thereof, track operator, track owner, officials, car owners, drivers, pit crews, any persons in any restricted area, promoters, sponsors, advertisers, owners and lessees of premises used to conduct the event and each of them, their officers and employees, all for the purpose herein referred to as releases, from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releases or otherwise while the undersigned is in or upon the restricted area, and/or, competing, officiating in, observing, working for, or for any purpose participating in the event.

**2. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS** the releases and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in or upon the restricted area or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by the negligence of the releases or otherwise.

**3. HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE** due to the negligence of releases or otherwise while in or upon the restricted area and/or while competing, officiating, observing, or working for, or for any purpose participating in the event.

**EACH OF THE UNDERSIGNED** expressly acknowledges and agrees that the activities of the event are very dangerous and involve the risk of serious injury and/or death and/or property damage. EACH OF THE UNDERSIGNED further expressly agrees that the forgoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the Province or State in which the event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding continue in full legal force and effect.

**THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT**, and further agrees that no oral representations, statements or inducements apart from the forgoing written agreement have been made.

GENERAL TRACK RULES & GUIDELINES**

**Track Hours of Operation**

The Santa Maria Kart Track is open for use to our members all year long, except for during special events scheduled at track. Please check the track calendar at [www.smka.org](http://www.smka.org) periodically for hour of operation and special events that have been added.

**Camping**

No overnight camping is allowed at the Santa Maria Kart Track except for during special events scheduled at track.

**Track Sign In**

Each time the track is used, all members (except minors) must sign the *RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT* upon arrival to the track. At the top of the form, please write "SMKA Practice Day" and the date. At the bottom of the form, all members (except minors) must print and sign their name. **It is very important that all members complete this paperwork each time the track is used.** This paperwork is available inside the brown box on the side of the sea container near the Grid. Insert completed paperwork into the slot found below the brown box.

**Minor Release Forms & Birth Certificates**

All minors that are SMKA members will be required to submit a notarized copy of the IKF Minor Release Form. This form can be downloaded at <http://ikfkarting.com/OfficePages/PDFs/Forms/MinorReleaseForm.pdf>. In addition, a birth certificate for all minors must be submitted and kept on file at the SMKA registration office.

**Gate Code**

Each member will receive two gate codes that operate the two separate gates to the track. **Do not share the gate codes with anyone or it may result in your membership being suspended.** One or both of the gate codes will be changed throughout the year. The gate codes will be sent to you by email or text. Please provide your email address or text number below:

**Safety**

All drivers must have proper safety equipment when using the track. This includes helmet, neck brace, driving suit or jacket & pants, gloves and high-cut shoes/boots. Children 12 years old and under must wear a chest protector.

**Guests**

*Track Membership* holders are allowed to bring guest drivers to the track. Names of all guest drivers and non-driver must be emailed prior to going to track to [info@smka.org](mailto:info@smka.org). Please label Subject of email as "Guest Drivers". The track use fee for guest drivers is \$45/day. The fee for guests that are not driving is \$10/day. Mail payment to SMKA within 1 week (see [www.smka.org](http://www.smka.org) for address). Guest drivers will need to sign *RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT* form. If guest driver is a minor, Minor Release Form will need to be completed at track.
